- Affiliate membership fees & benefits: ICA does not currently require TDs/Coach to be affiliates to advertise on ICA website (only ICA members or separate listing charge). Discussion to require affiliate membership in order to advertise on website, and potential additional benefits (such as a free ad).
- Potential Benefits: Send out formal paper certificates acknowledging affiliate membership (similar to process by ACE Chess Equipment). Rachel is willing to run this program.
- Steve will create ICA Affiliate Logo for use on certificates and to offer for use at events.
- Rachel welcomes suggestions for the Meet the Members column.
- Rachel provided a brief overview of the program
   Chess in Schools (CIS) and will create a brief article for the ICA website.

#### d. Treasurer (Steve):

• **Corporate Tax Returns:** Steve spoke with accountant Arthur Gunn and he is willing to file tax returns. He will not assist with Quikbooks.

#### **B.** Committee Reports

#### a. WJP/RS (Rose):

- Succession Planning: Rose will be stepping down as director as of September 1<sup>st</sup> and will be emailing current program parents to inquire if someone/groups would be interested in directing WJS/RS program. Prior to leaving she will establish the 2020-2021 class.
- Youth Invitational: The Youth Invitational is this
  weekend with 46 players registered (but two dropouts
  due to illness). The Haring section player has been
  replaced, but Rose is still working on a replacement
  for the Denker section. Trophies have been ordered,
  and winners will still retain travel stipends (but not
  coaching stipends).
- Finances: Congratulations to Rose for securing the Mander Foundation grant! Rose will find the articles posted about receiving the Mander Grant in previous years and will use as template for article on ICA website this year.
- **Sunday Night Training:** 3 training dates scheduled for March and May (none for April due to spring break).
- WJS/RS Banquet: will not be held at Naperville North (no longer available).

#### VI. Open Issues

- a. **Inventory of all ICA assets:** Steve picked up some chess sets following a tournament last month and is working on facilitating pick-up of remainder. He has begun inventory.
- b. **Editor:** The current Editor is not interesting in drafting articles. Steve proposed adding cross table/article requirements to bid requirements. Rose suggested asking the Bid Committee for their thoughts. USCF requires organizers to write articles for select Chess Tournaments.

c. **Liability Insurance:** Steve will reach out to his agent to compare if his chess organizer liability insurance has any good options for ICA liability insurance.

#### VII. New Business

a. TD/Coach Lists: The board discussed how to increase incentives for ICA Affiliates. The board discussed requiring those listed as TD/Coaches to register for ICA Affiliate memberships (instead of regular ICA membership or fee). Affiliate incentives could include a potential complimentary ad for a week, listing as TD/Coach, and a formal certificate. Rachel will work on putting together an Affiliate package, and the board will vote next meeting on potential benefits and membership requirements for listings.
